STUD SERVICE CONTRACT

Thank you for expressing an interest in using Surf City Bulldogs in your breeding program. Before a commitment for breeding is made please consider the following:

Prior to a breeding agreement, we require from you:

- 1. A photocopy of your bitch's AKC registration.
- 2. A legible four-generation pedigree.
- 3. Recent photograph and/or video tape of the bitch.
- 4. That your bitch be in a healthy condition, and deemed breedable by your Veterinarian.

Prior to an agreement to breed, our responsibilities to you are as follows:

- 1. Have stud dog in excellent health and available at proper time for breeding.
- 2. To provide a photocopy of our stud's AKC registration.
- 3. A copy of his three generation certified AKC pedigree.

Following an agreement to breed, it is required that you:

- 1. Provide a record of current vaccinations including Rabies and Bortadella.
- Pay all veterinary costs, at the time of service. This may include vaginal smears, progesterone testing, artificial insemination and any other veterinary care the bitch may require.
- Stud Dog owner requires that the puppies resulting from this breeding be sold or
 placed with AKC Limited Registration with Spay/Neuter contracts. Breeder will be
 fined the amount of \$1,000.00 per puppy sold on Open AKC Registration. Any
 and all resulting court costs will be the sole responsibility of Breeder.

- 4. It is also **strongly** advisable to sell your non-show puppies on AKC Limited as well as Spay/Neuter contract in order to protect your breeding program. Contracts for your puppies sold/placed should include a "First Right of Refusal" clause, in the event that the buyer ever needs to let go of your puppy at any time.
- 5. Agree that puppies resulting from this breeding shall not knowingly be sold either directly to, or to an agent thereof, an individual who sells outright or consigns to a pet shop, kennel, or individual whose purpose is mass production, wholesaling, or retailing of purebred dogs. Any deviation from this clause will result in legal action by the stud dog owner to obtain control and title of the entire litter. ______ (breeder initials)
- 6. Due to the love, and time that are involved in the breeding of Bulldogs, and for safety purposes relating to all involved, it is preferred that puppies sired by my dog <u>not</u> be sold through newspaper or internet advertising. I will assist with finding suitable homes if assistance is needed through the Bulldog Club of America Breeder Referral program. I am listed nationally as BCA Breeder Referral Volunteer.

All proposed bitches must meet the following criteria:

- 1. The bitch must be in good physical condition, be at least 18 months of age, no older than 5 years, and have had no more than 2 previous litters.
- 2. The bitch must have a stable temperament.
- 3. The bitch must have no genetically derived disqualifying faults.

4. The bitch must be AKC registered.

STUD SERVICE POLICY

- 1. The stud fee for this breeding will be the sum of \$800, paid before first breeding.
- 2. One or more live puppies, constitutes a litter.
- 3. A later return service is available to the same bitch in a later heat, to the same stud dog, if one or more puppies do not result from this breeding.
